# Guidance Notes on the Use of The Standard Tender Document

These guidance notes have been prepared by the CPTU to assist an Employer in the preparation of Standard Tender Document for the procurement of Non-Consulting Services (hereinafter referred to as STD (PSN)), having estimated costs of any value. The Employer should also refer to the Public Procurement Act 2006 (Act No 24 of 2006) and the Public Procurement Rules, 2008, issued to supplement the Act available on CPTU's website: <http://www.cptu.gov.bd/>. All concerned are advised to refer to the aforementioned Act and Rules and subsequent amendment thereof while participating in any Tendering process. STD (PSN) is based upon internationally acceptable model formats, which have been adapted to suit the particular needs of procurement within Bangladesh.

The use of STD (PSN) applies when a Procuring Entity (PE)/employer/purchaser intends to select a Tenderer/ a Service Provider for the Procurement of non-consulting services under Open Tendering Method (OTM) while the contract award is being determined based on lowest evaluated responsive Tender and when a pre-qualification process has not taken place.

The Employer addresses its specific needs through the information provided in the Tender Data Sheet (TDS) and the Particular Conditions of Contract (PCC) as well as in the Activity Schedule and the Performance Specifications/scope of services/Drawings.

Guidance notes in brackets and italics are provided for both the Employer and the Tenderer and as such the Employer should carefully decide what notes need to remain and what other guidance notes might be required to assist the Tenderer in preparing its Tender Submission The Invitation for Tenders (IFT) is provided in this Tender Document for information only.

The non-Consulting Service, among other physical services, may include the Services based on Information and Communication Technology, Janitor, Catering, Transport, Cleaning, Security, Survey/Investigation/Data Collection, Courier, Testing, Facilitating event management (Workshop/Seminar/Symposium/Congregation etc.), Training, Travel, Insurance, Washing and Laundry, Tailoring and similar other stand-alone services, pre-shipment inspection, C&F services, Hiring of manpower, geological survey or exploratory drilling, operations & maintenance of building, equipment & hiring of office/accommodation/ space etc.

STD (PSN) when properly completed will provide all the information that a Tenderer needs in order to prepare and submit a Tender. This should provide a sound basis on which the Employer/purchaser can fairly, transparently and efficiently carry out a Tender evaluation process on the Tenders submitted by the Tenderers.

STD (PSN) has 7 Sections, of which **Section 1: Instruction to Tenderer** and **Section 3: General Conditions of Contract** must not be altered or modified under any circumstances.

The following briefly describes the Sections of STD (PSN) and how an Employer should use these when preparing a particular Tender Document.

## **Section 1. Instructions to Tenderers (ITT)**

This Section provides relevant information to help Tenderers prepare their Tenders. Information is also provided on the submission, opening, and evaluation of Tenders and on the award of Contract. The Instruction to Tenderer (ITT) specifies the instructions and procedures that govern the tendering process. This Section also contains the criteria to be used by the Employer to determine the lowest evaluated Tender and the qualifications of the Tenderer to perform the Contract. The Instructions to Tenderer (ITT) are therefore not a part of the Contract. **(The text of the Clauses in this Section shall not be modified.)**

## **Section 2. Tender Data Sheet (TDS)**

This Section provides the information that is specific to each object of procurement and that supplements the information or requirements included in **Section 1: Instructions to Tenderers**. The Employer shall specify in the TDS only the information that the ITT instructs to be specified in the TDS. To facilitate the preparation of the TDS, its Clause Numbers are numbered with the same numbers of the corresponding ITT Clauses.

## **Section 3. General Conditions of Contract (GCC)**

This Section provides the General Conditions of Contract that will apply to the Contract for which the Tender document is issued. The GCC clearly identifies the provisions that may normally need to be specified for a particular tendering process and need to be addressed through the PCC. **(The text of the clauses in this Section shall not be modified.)**

## **Section 4. Particular Conditions of Contract (PCC)**

This Section provides clauses specific to the particular Contract that modify or supplement **Section 3: General Conditions of Contract**. The Employer should include at the time of issuing the Tender Documents all information that the GCC indicate, shall be provided in the PCC. No PCC Clause should be left blank. To facilitate the preparation of the PCC, its Clause Numbers are numbered with the same numbers of the corresponding GCC Clauses.

## **Section 5. Tender and Contract Forms**

All tender and contract forms are given in Section 5. Those are from PSN-1 to PSN -9 as follows:

PSN 1- Tender Submission Form

PSN 2- Tenderer Information Form

PSN 3 – Personnel Information Form

PSN 4 – Bank Guarantee for Tender Security

PSN 5- Letter of Commitment for Bank's undertaking for Line of Credit

PSN 6 – Letter of Acceptance (LOA)

PSN 7 – Contract Agreement

PSN 8 – Bank Guarantee for Performance Security

PSN 9 – Bank Guarantee for Advance Payment

In this section the detailed activity schedule is provided for the guidance of the service provider.

## **Section 7: Performance Specification and Drawings**

In this section a framework has been incorporated that needs to be customised as per the type of physical service that is required to be provided.

# Section 1. Instructions to Tenderers

## A. General

1. Scope of Tender	<p>1.1 The Procuring Entity, as indicated in the Tender Data Sheet (TDS) issues this Tender Document for the procurement of non-Consulting Services as specified in the <b>TDS</b> and as detailed in <b>Appendix A</b> to the Contract. The name of the Tender and its number and identification is stated in the <b>TDS</b>.</p> <p>1.2 The successful Tenderer will be expected to complete the performance of the Services by the Intended Completion Date as stated in the <b>TDS</b>.</p>
2. Interpretation	<p>2.1 Throughout this Tender Document:</p> <ul style="list-style-type: none"> <li>(a) the term “in writing” means communication written by hand or machine duly signed and includes properly authenticated messages by facsimile or electronic mail;</li> <li>(b) if the context so requires, singular means plural and vice versa;</li> <li>(c) “day” means calendar days unless otherwise specified as working days;</li> <li>(d) “Person” means and includes an individual, body of individuals, sole proprietorship, partnership, company, association or cooperative society that wishes to participate in Procurement proceedings;</li> <li>(e) “Tenderer” means a Person who submits a Tender;</li> <li>(f) “Tender Document” means the Document provided by a Procuring Entity to a Tenderer as a basis for preparation of the Tender; and</li> <li>(g) “Tender” depending on the context, means a Tender submitted by a Tenderer for execution of Works and physical services to a Procuring Entity in response to an Invitation for Tender</li> </ul>
3. Source of Fund	<p>3.1 The Procuring Entity has been allocated public funds as indicated in the <b>TDS</b> and intends to apply a portion of the funds to eligible payments under the Contract for which this Tender Document is issued.</p> <p>3.2 For the purpose of this provision, “public funds” means any monetary resources appropriated to the Procuring Entity under Government budget, or loan, grants and credits placed at the disposal of the Procuring Entity through the Government by the development partners or foreign states or organisations.</p> <p>3.3 Payments by the development partner, if so indicated in the TDS, will be made only at the request of the Government and upon approval by the development partner or foreign state or Organisation in accordance with the applicable Loan / Credit / Grant Agreement, and will be subject in all respects to the terms and conditions of that Agreement.</p>

<p>4. Corrupt, Fraudulent, Collusive or Coercive Practices</p>	<p>4.1 The Government requires that Procuring Entities, as well as the Tenderers shall, during the procurement proceedings and the execution of Contracts under public funds, ensure-</p> <ul style="list-style-type: none"> <li>a. strict compliance with the provisions of Section 64 of the Public Procurement Act 2006 including amendments thereto;</li> <li>b. abiding by the code of ethics as mentioned in the Rule 127 of the Public Procurement Rules, 2008 including amendments thereto;</li> <li>c. That neither it is any officer nor any staff or any other agents or intermediaries working on its behalf engages in any practice as detailed in the Rule 127.</li> </ul> <p>4.2 If corrupt, fraudulent, collusive or coercive practices of any kind is determined by the Procuring Entity against any Tenderer alleged to have carried out such practices, the Procuring Entity shall:</p> <ul style="list-style-type: none"> <li>a. exclude the concerned Tenderer from further participation in the particular procurement proceeding; or</li> <li>b. reject any recommendation for award that had been proposed for that concerned Tenderer; or</li> <li>c. Declare, at its discretion, the concerned Tenderer to be ineligible to participate in further procurement proceedings, either indefinitely or for a specific period of time.</li> </ul>
<p>5. Eligible Tenderers</p>	<p>5.1 This Invitation for Tenders is open to all potential Tenderers.</p> <p>5.2 Tenderers shall have the legal capacity to enter into the Contract under the Applicable Law.</p> <p>5.3 Tenderers shall be enrolled in the relevant professional or trade organisations registered in Bangladesh.</p> <p>5.4 Tenderers may be a physical or juridical individual or body of individuals, or company invited to take part in public procurement or seeking to be so invited or submitting a Tender in response to an Invitation for Tenders.</p> <p>5.5 Tenderers shall have fulfilled its obligations to pay taxes under the provisions of laws and regulations of Bangladesh.</p> <p>5.6 Tenderers and all parties constituting the Tenderer shall not have a conflict of interest.</p> <p>5.7 Tenderer in its own name or its other names or also in the case of its Persons in different names, shall not be under a declaration of ineligibility for corrupt, fraudulent, collusive or coercive practices as stated under ITT Clause 4.2.</p>
<p>6. Site Visit</p>	<p>6.1 Tenderers, at the Tenderers' own responsibility and risk, are encouraged to visit and examine the Site of required Services and its surroundings and, obtain all information that may be necessary for preparing the Tender and entering into a contract for the Services. The costs of visiting the Site shall be at the Tenderers' own expenses.</p>

<b>B. Tender Document</b>	
7. Tender Document	<p>7.1 The Sections comprising the Tender Document are listed below, and should be read in conjunction with any Addendum issued under <b>ITT Clause 9</b>.</p> <ul style="list-style-type: none"> <li>a. Section 1 Instructions to Tenderers (ITT)</li> <li>b. Section 2 Tender Data Sheet (<b>TDS</b>)</li> <li>c. Section 3 General Conditions of Contract (GCC)</li> <li>d. Section 4 Particular Conditions of Contract (<b>PCC</b>)</li> <li>e. Section 5 Tender and Contract Forms</li> <li>f. Section 6 Activity Schedule/</li> <li>g. Section 7 Performance Specifications and Drawing</li> </ul>
8. Clarification of Tender Document	<p>8.1 A prospective tenderer requiring any clarification of the Tender Document shall contact the Procuring Entity in writing at the Procuring Entity's address and, within time as specified in the <b>TDS</b>.</p>
9. Addendum to Tender Document	<p>9.1 At any time prior to the deadline for submission of Tenders, the Procuring Entity on its own initiative or in response to a clarification request in writing from a Tenderer, may revise the Tender Document by issuing an Addendum.</p> <p>9.2 The Addendum issued under ITT Sub Clause 9.1 shall become an integral part of the Tender Document, shall have a date and an issue number, and must be circulated by fax, mail or e-mail, to Tenderers who have purchased the Tender Documents, within five (5) working days of issuance of such Addendum, to enable Tenderers to take appropriate action.</p> <p>9.3 If an Addendum is issued when time remaining is less than <b>one-third</b> of the time allowed for the preparation of Tenders, the Procuring Entity at its discretion shall extend the deadline by an appropriate number of days for the submission of Tenders, depending upon the nature of the Procurement requirement and the addendum. In any case, the minimum time for such extension shall not be less than three (3) working days.</p>
<b>C. Qualification Criteria</b>	
10. General Criteria	<p>10.1 Tenderers shall possess the necessary professional and technical qualifications and competence, financial resources, equipment and other physical facilities, managerial capability, specific experience, reputation, and the personnel, to perform the contract, which entails setting pass/fail criteria, which if not met by the Tenderers, will result in consideration of its Tender as non-responsive.</p> <p>10.2 In addition to meeting the eligibility criteria, as stated under ITT Clause <b>5</b>, Tenderers must satisfy the other criteria stated in ITT Clauses <b>10 to 16</b> inclusive.</p>

11. Experience Criteria	<p>11.1 Tenderers shall have the following minimum level of experience to qualify for the performance of the non-Consultant Service under the Contract:</p> <ul style="list-style-type: none"> <li>a. a minimum number of years of general experience in contracting industries in public sector as Prime Contractor/Sub Contractor/Management Contractor as specified in the <b>TDS</b>;</li> <li>b. a minimum number of years of specific experience <b>(to comply with this requirement service contracts cited should be at least 70 percent complete)</b> as Prime Contractor in providing non-Consulting Service of a nature, complexity and methods/technology similar to the proposed non-Consulting Service in at least a number of contracts over the period, as specified in the <b>TDS</b>.</li> </ul>
12. Financial Criteria	<p>12.1 Tenderer shall have the following minimum level of financial capacity to qualify for the performance of the Services under the Contract.</p> <ul style="list-style-type: none"> <li>(a) the average annual turnover as specified in the <b>TDS</b> during the period specified in the <b>TDS</b>;</li> <li>(b) availability of minimum liquid assets i.e. working capital or credit line(s) from any scheduled Bank of Bangladesh, net of other contractual commitments, of the amount as specified in the <b>TDS</b>.</li> </ul>
13. Personnel Capacity	<p>13.1 Tenderers shall have the minimum level of personnel capacity to qualify for the performance of the Services under the Contract consisting of key personnel with qualifications and experience as specified in the <b>TDS</b>.</p>
14. Equipment Capacity	<p>14.1 Tenderers shall own suitable equipment and other physical facilities or have proven access through contractual arrangement to hire or lease such equipment or facilities for the desired period, where necessary or have assured access through lease, hire, or other such method, of the essential equipment, in full working order, as specified in the <b>TDS</b>.</p>
15. Joint Venture	<p>15.1 No Joint Venture (JV) shall be permissible under this Invitation for Tenders. Tenders submitted in the form of JV shall be considered non-responsive.</p>
16. Sub-contractor	<p>16.1 The successful Tenderer shall under no circumstances assign the services or any part of it to the Subcontractor(s).</p>
<b>D. Tender Preparation</b>	
17. Only One Tender	<p>17.1 Tenderers shall submit only one (1) Tender for each package. Tenderer who submits or participates in more than one (1) Tender in one (1) package will cause all the Tenders of that particular Tenderer to be considered non-responsive.</p>

18. Cost of Tendering	<p>18.1 Tenderers shall bear all costs associated with the preparation and submission of its Tender, and the Procuring Entity shall not be responsible or liable for those costs, regardless of the conduct or outcome of the Tendering process.</p> <p>18.2 The Procuring Entity shall make Tender Documents available immediately to the potential Tenderers, requesting and willing to purchase at the corresponding price by the date the advertisement has been published in the newspaper.</p>
19. Language of Tender	19.1 The Tender shall be written in the English language. Correspondences and documents relating to the Tender may be written in English or Bangla.
20. Contents of Tender	<p>20.1 The Tender prepared by the Tenderer shall comprise the following:</p> <ol style="list-style-type: none"> <li>a. Tender Submission Letter (<b>Form PSN-1</b>) as stated under ITT Sub Clause 21.1;</li> <li>b. Tenderer Information (<b>Form PSN-2</b>) as furnished in Section 5: Tender Forms;</li> <li>c. the Priced Activity Schedule as stated under ITT Sub Clause 21, 22 and 23;</li> <li>d. the Tender Security as stated under ITT Clauses 26 and 27.</li> <li>e. the written confirmation authorizing the signatory of the Tender to commit the Tenderer, as stated under ITT Sub Clause 30.2;</li> <li>f. the Valid Trade License;</li> <li>g. documentary evidence of Tax Identification Number(TIN) and VAT as a proof of fulfilment of taxation obligations as stated under ITT Sub Clause 5.5;</li> <li>h. documentary evidence as stated under ITT Clause 24 establishing the Tenderer's eligibility and minimum qualifications required to be met for due performance of the physical services under the Contract; and</li> <li>i.
